Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The statute also provides that, while public housing authorities may change or modify their plans or policies described in them, any “significant amendment or modification” to the plan would require public housing authorities to submit a revised PHA Plan that has met full public process requirements. PLHA is amending its definition of Substantial Deviation and Significant Amendment as such:</p> <p>Substantial Deviation A substantial deviation may be defined as a loss and/or inadequate funding for a program, reallocation of funding to sustain programs and/or a change in regulatory requirements governing a program, thus requiring PLHA to amend its agency plan. As part of the conversion process, PLHA is redefining the definition of a substantial deviation from the PLHA Plan to exclude the following Section 18 and RAD-specific items:</p> <ol style="list-style-type: none"> Changes to the Capital Fund Budget produced as a result of each approved RAD/ Section 18 Conversion, regardless of whether the proposed conversion will include use of additional Capital Funds; Changes to the Relocation Plan and processes for each approved RAD/ Section 18 conversion; Changes to the construction and rehabilitation plan for each approved RAD/ Section 18 conversion; Changes to the financing structure for each approved RAD/ Section 18 conversion; Changes to the CHAPs either adding or removing units and/or modifying timeframes; The decision to convert to either Project Based Rental Assistance or Project Based Voucher Assistance; and Changes to the Section 18 Disposition Plan and/or application for units identified in this plan. <p>Significant Amendment/ Modification PLHA will amend or modify its agency plan upon the occurrence of any of the following events during the first nine months of the term of an approved plan:</p> <ol style="list-style-type: none"> A federal statutory or regulatory change is made effective and, in the opinion of the Authority, has either substantial programmatic or financial effects on the programs administered by PLHA, or creates substantial obligations or administrative burdens beyond the programs under administration at the start of the Plan year. Proposed demolition, disposition, homeownership, Capital Fund Financing, development, or mixed finance proposals not already identified in this plan and those that are considered by HUD to be significant amendments to the Agency Plan and CFP 5 Year Action Plan. If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan.</p> <p>Manhattan Housing Authority (MHA) is in the process of converting some of its Public Housing portfolio under the Section 18 Demolition and Disposition program.</p> <p>Manhattan Housing Authority is in the process of applying for Section 18 Obsolescence Disposition Approval for Carlson Plaza (KS06300001), a 47-unit family public housing development located 425 Pierre Street in Manhattan, Kansas. The property was constructed in 1975 and consists of 46 one-bedroom units (475 NSF) and one (1) two-bedroom units (950 NSF) on a 0.7-acre site. The unit #s are as follows: 1C, 1D, 1F, 1G, 1H, 1J, 1K, 2A, 2B, 2C, 2D, 2E, 2F, 2G, 2H, 2J, 2K, 3A, 3B, 3C, 3D, 3E, 3F, 3G, 3H, 3J, 3K, 4A, 4B, 4C, 4D, 4E, 4F, 4G, 4H, 4J, 4K, 5A, 5B, 5C, 5D, 5E, 5F, 5G, 5H, 5J, and 5K. . Manhattan Housing Authority will apply for Tenant Protection Vouchers for all 47 units, which will be project-based to finance the redevelopment of a proposed newly constructed 9% multifamily project.</p> <p>The project will be applying for a 9% Low Income Housing Tax Credit preliminary application/approval in Q1 2025 through the Kansas Housing Resource Corporation. If the project is successful in the preliminary stage, it will receive an invitation to Submit a Full Low Income Housing Tax Credit application in Q3 2025. The proposed project will replace and/or increase the number of residential units on the property. At financial closing, the land will be transferred via a long-term ground lease to a new Special Purposes Entity (LLC) controlled by the Authority for the purpose of redeveloping the site. The property currently contains 3 fully accessible units (2C, 2D, and 3D. Manhattan Housing Authority will replace these one-for-one the accessible units as part of the new construction project.</p> <p>Manhattan Housing Authority will submit the Section 18 Disposition Application for Carlson Plaza in Q1 2024. Financial closing is anticipated for Q4 2025.</p> <p>Manhattan Housing Authority intends to use funds from the disposition of Public Housing to support new acquisition activities to provide affordable housing opportunities.</p> <p>Upon conversion, the unit types, bedroom sizes, and number of units in each category will remain the same.
